CONTEST RULES AND REGULATIONS

Company organizer of the Contest: GONZALEZ BYASS, S.A., (hereinafter GONZALEZ BYASS or the Organizer) with domicile in the street Manuel María González 12, Jerez de la Frontera (SPAIN), and C.I.F. A11605276, intends to carry out, through the competition system, a promotional action called "LEGENDS OF LONDON", in order to encourage the diffusion and notoriety of its brand THE LONDON N°1 OFICIAL BLUE GIN (hereinafter TLN1) and to promote and make known the different uses of its product TLN1 as an ingredient of multiple and varied cocktail recipes through the web www.legendsoflondon.com.

The Competition will be governed by the following bases:

1. - THE COMPETITION:

The **Legends of London** is international The London No. 1 gin cocktail competition, which is launch in 15 countries, including Brazil, Colombia, Perú, Mexico, Chile, Belgium/Netherlands*, Denmark, Germany, Italy, UK, Czech Republic/Slovakia**, Switzerland, Spain, Indonesia & Malaysia.

***Belgium & Netherlands will participate as a single country, resulting only one finalist between these 2 countries for the international final in London.**

****Czech Republic & Slovakia** will participate as a single country, resulting only one finalist between these 2 territories for the international final in London.**

Professional active bartenders, over 18 years of age, can participate and become the countries mentioned.

Notwithstanding the foregoing, the Contest is not valid in any country or place where state or local laws or regulations are prohibited.

The competition is made up of 2 stages:

- **National competitions** will be held in each participating country. To enter the Competition, candidates must register on the website, submit their cocktails recipes, photos and a video demonstrating their bartender's ability. The jury will select finalists per country from among all the candidates, who will represent their country at the International Final.

- The **International Final**, to be held on the 14th of October 2019 in London, England, where National Finalists will compete to become the winner of **Legends of London 2019**.

Notwithstanding the foregoing, the Contest is not valid in any country or place where state or local laws or regulations prohibit it.

Those who are linked by labor or commercial relationship to GONZALEZ BYASS, or workers or collaborators of the entities that have a relationship with the Contest and the prize to be delivered, or their family members up to the second degree, cannot participate in the Contest. Consanguinity or affinity, or spouse or relationship of a similar nature.

Neither may any person directly or indirectly involved in the preparation, design, organization and/or operation of this promotion and advertising agencies or promotion agencies that are related to The Contest, nor minors in each of the countries and non-residents legally in these countries.

Subsequent to its inception, said promotion may be communicated in any other means That GONZALEZ BYASS deems appropriate, press, digital media, etc.

3. – MECHANICS OF THE CONTEST

3.1. REGISTRATION OF PARTICIPATION IN THE WEBSITE

Those interested in participating in the Contest and who meet the requirements established in Base 1 above, must register, within the period between June the 3rd (12: 00: 00h CEST UTC + 2) and July 31st, 2019 (23: 59: 59h CEST UTC + 2) at

www.legendsoflondon.com, filling in all the mandatory fields of the registration form and accepting the Bases of the Contest.

Inaccurate, erroneous data or that in the date of the Competition will not be in force will not be admitted. Participants who do not meet all the requirements indicated in the present rules will not be entitled to any prize.

3.2. METHOD OF PARTICIPATION – PHASE 1

To participate in the contest, once the registration has been made on the website and the bases accepted, the participant will have access to a personal area on the web to register, no later than July the 31st 2018, his cocktail proposal, Following the rules and regulations stipulated by the competition, along with a photograph of the cocktail.

Proposals submitted by participants must meet the following requirements:

- Cocktail has to contain at least 35ml of TLN1.
- Maximum of 7 ingredients, including garnish (*).
- Cocktail registration must include the name of the cocktail, complete recipe in ml, a photo of cocktail and inspiration of the creation.

(*) It will not be considered an ingredient the ice that the contestants think fit, in addition to the decorative complements (straws, removers, etc).

The methods of elaboration are at the participant's desire.

The cocktail will have to be an original combination of the participant's own.

The same participant can only participate in a cocktail.

No prized or pending cocktail can be presented in another contest.

Each bartender will have to create cocktail following the general rules, with no or minimum wastage (including plastic waste, fruit waste, etc.)

3.3. CHOICE OF WINNERS – PHASE 1

A jury, selected and freely chosen by the organizer, will choose from among the proposals received between 3rd June and 31st July 2019, a winning cocktail for each participating country.

The jury will make its decision according to the following criteria:

- Presentation
- Harmonization of the combination of different ingredients
- Inspiration for the creation presented
- SUSTAINABLE APPROACH

The jury will also choose three reservations or alternates.

The members of the jury will decide on any controversy that arose during the development of the contest and the application of the present bases.

The participants are bound to the interpretation of the selection criteria made by the jury, accepting the decision of the same, as well as that there is no claim or complaint within the scope of this contest.

The jury may declare desierto the contest of not being reached, in its opinion, a certain level in the recipes with respect to the indicated criteria.

The decision of the jury will be made public on August 2, 2019. GONZALEZ BYASS will contact the winners of Phase 1 of the competition by email. The winner, within the next 5 calendar days, must confirm that he / she agrees to move to Phase 2 of the Contest by sending a communication by the means indicated by GONZALEZ BYASS at that moment, where they must make a commitment to include and maintain, In the cocktail menu of the place where they perform their professional activity, for a period of at least 3 months, the cocktail they have presented and chosen to move to the next phase of the Contest. GONZALEZ BYASS may request the participants to prove the effective fulfillment of this commitment, by sending a photograph of the letter.

If the winner does not respond within the period indicated, does not assume the indicated commitment, or could not contact GONZALEZ BYASS, he will lose the right to participate in Phase 2 of the Contest and this will pass to the reserves by his order, who will have the Same time period for acceptance.

You will also lose the right to pass to Phase 2 of the Contest, those participants who have registered on the portal <http://www.legendsoflondon.com> with non-truthful or false data and those that do not comply with the provisions in the present bases and Have been disqualified. In such case, the next participant from the same country that has obtained the next highest score will be declared the winner of Phase 1 of that country.

3.4. METHOD OF PARTICIPATION – PHASE 2

The winner in each of the national finals, prior express acceptance as indicated in the previous section 3.3., you will enter the final round of the competition to be held in the city of London on October the 14th, 2019.

GONZALEZ BYASS will be responsible for the following expenses of travel, lodging, and maintenance of the participants, necessary for their participation in Phase 2 of the Contest, as well as in the complementary activities organized by GONZALEZ BYASS:

- DAY 1 (13 October 2019): Arrival in London during the morning and planned activities throughout the day.
- DAY 2 (14 October 2019): International final in London and activities during the day.
- DAY 3 (15 October 2019): Return flight.

2 hotel nights in London (4 * hotel or higher), return flights from the nearest airport to the city of residence of the participants, transfer from the airport to the hotel and from the hotel to the airport***, transfers in the city of London according to the schedule set by the organizers, lunch and dinner on day 1, breakfast and lunch on day 2, breakfast on day 3, and expenses corresponding to the activities established by the organizer.

***** Transfer from the airport to the hotel and from the hotel to the airport will be only cover in London and between October the 13th to October the 15th 2019.**

The finalists must have their passport or current identification document, as well as the relevant visa and all suitable vaccines, if necessary, proving these extremes by submitting the documentation corresponding to GONZALEZ BYASS or to the Travel Agency designated by the latter.

GONZALEZ BYASS reserves the right to modify the travel plan previously indicated, for which purpose it will notify participants in due time.

Participants in this international final will face an international jury composed of experts from the world of mixology and spirits.

The competition will consist of the elaboration, by each of the participants selected in Phase 1, of the winning cocktail in the national competition:

- a) each participant will elaborate two units of the cocktail to be presented to the jury.
- b) each participant will have a maximum time of 5 minutes to prepare his proposal.

3.5. CHOICE OF THE WINNER – PHASE 2

The evaluation of the Jury will be carried out taking into account the characteristics of the cocktail that are related below. The maximum total score that can be awarded to a cocktail is 100 points, distributed as follows:

In case of a tie in the scores, the jury will re-evaluate the performance and proposals of the participants matched to points.

The highest scoring participant will be proclaimed an international Legends of London winner.

If the winner of Phase 2 was disqualified for any reason, the next highest rated participant will be declared the winner of the competition.

4. – PRIZE

The winner of Phase 2 of the Competition will be awarded a trophy that will credit him as the absolute winner of the 3rd edition of Legends of London and will receive a cash prize worth 1,600 Euros.

The prize for this promotion is personal and non-transferable. The prize cannot be subject to exchange, alteration or compensation at the request of the winner.
